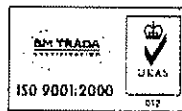

The company's net profit up to end of the 2009 was AED 80,811,261 compared to AED 195,634,595 same period last year 2008.


Basic earnings per share as the end of the 2009 was AED 0.23 Fils compared to AED 0.55 Fils same period last year 2008.

The company does not have any local investments in UAE or outside UAE.

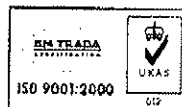
There are no deposits in foreign banks abroad.
